America's leading advocate for oral health

The following is an ongoing feature in the SCDA Bulletin that features leaders from the SCDA past. This month features Dr. George P. Hoffmann, Jr., who was quite a driving force in the SCDA. After his unexpected death representing the SCDA at an ADA council meeting in Chicago in 1977, the SCDA conveived the George P. Hoffmann Award to recognize an outstanding SCDA member whose service to the profession and the community emulate the ideals that Dr. Hoffmann stood for in his life. It is the highest award that the Association gives to a member dentist. Because of Dr. Hoffmann's many contributions to the profession, his portrait is in the conference room at the SCDA Headquarters building.



Dr. George Hoffmann, Jr.

Dr. George P. Hoffmann, Jr. has been one of the most dynamic and outstanding leaders to serve in the South Carolina Dental Association. He was indeed a visionary in representing our association through the years.

Dr. George Hoffmann, Jr. was born in 1922 in Anderson, South Carolina to George P. and Nan Martin Hoffmann. He attended high school in Meridian, Mississippi. This was followed by enrolling at Mississippi State University. Upon the death of his father in 1941, his mother moved the family back to South Carolina to the town of Fountain Inn. George then attended Clemson College. As Clemson was a military college at the time, his class was activated in 1945 into the United States Army, and he was deployed to Germany for post-World War II duty there.

Following a year in Germany he returned home and enrolled in dental school at Emory University's School of Dentistry and graduated from there in 1950. Following his graduation, Dr. Hoffmann was called back into the United States Army during the Korean War where he served as a Captain in the Dental Corps from 1950 to 1952 at Fort Bragg, North Carolina.

Dr. Hoffmann established his practice of general dentistry in Greenville, South Carolina in 1952. He has served as president of the Greenville County Dental Society and the Piedmont District Dental Society. From 1967 to 1968 he had the distinction of serving as president of the entire South Carolina Dental Association. One of his priorities as the SCDA president was the pursuit of a headquarters building for our association with enough space for all of our necessary operations. One of the most meaningful of all events that occurred that year was the matriculation of the first class of dental students at the College of Dental Medicine at the Medical University of South Carolina. This was the culmination of many years of efforts by the members of the SCDA for this to become reality.

Dr. Hoffmann was very active in his community as well as the dental profession. Early in his career he engaged in a public debate with Greenville's mayor, J. Kenneth Cass, over the issue of fluoridation for the Greenville water system. Ultimately the measure passed, and Dr. Hoffmann later served on the Greenville Water Commission. Dr. Hoffmann served on the Greenville County Board of Health as well as spearheaded the establishment of the Head Start program in Greenville County.

Dr. Hoffmann also served as the chairman of the Greenville Hospital System's Department of Dentistry. Additionally he was a visiting professor at the College

of Dental Medicine at the Medical University of South Carolina. Dr. Hoffmann was also the executive director of the South Carolina Dental Health Corporation as well as a member of the South Carolina Joint Underwriters leadership team.

In 1968 Dr. Hoffmann chaired the committee that updated and re-wrote the South Carolina Dental Practice Act

On the American Dental Association level, Dr. Hoffmann was on the ADA Council on Federal Dental Services where he served six years as its chairman, as well as was on the ADA Council on Insurance at the time of his untimely death in 1977.

Additionally Dr. Hoffmann served as a member of the Department of Defense's Dental Advisory Committee on Emergency Health Preparedness.

In 1968 the Greenville County Dental Society presented Dr. Hoffmann with an award for "Outstanding Service to the Community and the Profession."

For his outstanding service to the profession of dentistry, Dr. Hoffmann was inducted as Fellow in the American College of Dentists and the International College of Dentists.

During the formative years of the College of Dental Medicine at the Medical University of South Carolina, Dr. Hoffmann was invited to serve on the Dean's Advisory Board to help establish South Carolina's first dental school.

In the business community, Dr. Hoffmann was a member of the board of directors of the Southern Bank and Trust Corporation.

At the Westminster Presbyterian Church in Greenville, Dr. Hoffmann served as president of the adult Sunday School.

Dr. Hoffmann spent his spare time pursuing his hobbies of golf, boating, and mechanical tinkering. Dr. Hoffmann married the former Shadie Armstrong of Greenville, and they had four children: Nancy M. Hoffmann, Dr. George Peter Hoffmann, III, also a dentist, James A. Hoffmann, and William A. Hoffmann. After their divorce in 1973, Dr. Hoffmann later married Linda K. Hucks.

Dr. George Hoffmann was indeed a tremendous leader and visionary for the noble profession of dentistry. After his untimely death in Chicago in 1977 while attending an American Dental Association Council meeting, the South Carolina Dental Association created the George P. Hoffmann Award. This award is given to an outstanding dentist in the SCDA whose service to the profession of dentistry and the community emulates the ideals that Dr. Hoffmann stood for in his life. This is the highest award that the SCDA can bestow upon one of its members. This honor is such a fitting tribute for one who did so much for so many.

It has been 30 years since I sat where you are sitting today. I did not arrive there or up here alone. Dozens and dozens of individuals lent me physical and financial assistance. They mentored me. They shared with me their successes and their failures, in order to

lighten my load along the way. However, they never failed to emphasize to me, in spite of my abilities and my accomplishments, my utmost responsibilities were to my profession, and more importantly, to the most vulnerable of my fellowmen.

My remarks today are not my own. Nor are they the words and lessons from my mentors. They are, however, taken directly and/or modified from the farewell addresses of Presidents George Washington and Barack Obama, and from remarks of Presidents Ronald Reagan and John Adams on the topics of our democracy, democratic organizations, voting, ethics, money, citizenship, our Constitution, freedom, self-government, liberty, and most importantly public service. What I have done, is relate their experience on these topics to our profession, organized dentistry, our Code of Ethics, autonomy, trust, and most importantly, our responsibility to our profession and our fellowmen. In these challenging times for our profession, this is what I have gleaned from their best advice. (For the sake of brevity, a slightly shorter version of this message was presented at the 2017 MUSC JBE CDM Hooding Ceremony.)

Always remember, our profession is threatened whenever we take it for granted. All of us, regardless of our specialty, should throw ourselves into the task of building and rebuilding our organized dental associations. When participation rates are declining and in some states are some of the lowest among the learned professions, we should make it easier, not harder, to join and participate. When trust in our profession is low, we should reduce the corrosive influence of money in our professions, and insist on the principles of transparency and ethics in service to our fellowmen. When any organized dental association is dysfunctional, we should draw upon all our districts to encourage our leaders to cater to common sense and not rigid extremes. And all of this depends on our participation; on each of us accepting the responsibility of being a learned professional, a doctor in the truest sense of the word, regardless of which way the pendulum of public opinion swings.

Our Code of Ethics is a remarkable, beautiful gift. But, it is only just a piece of paper without you. It has no power on its own. We the providers, the doctors, give it power or take away from it and from all of us - with our participation, or the lack thereof, and with the choices we make. Whether or not we stand up for our autonomy; whether or not we respect and enforce the rules of the learned professions; with much credit to our founders and our predecessors; Dentistry is no fragile thing. But the gains of our long journey to autonomy and the absolute trust of the public as a profession are not assured.

"In his own farewell address, George Washington wrote that self-government is the underpinning of our safety, prosperity, and liberty, but "from different causes and from different quarters much pains will be taken...to weaken in your minds the conviction of this truth;" that we should preserve it with "jealous anxiety;" that we should reject "the first dawning of every attempt to alienate any portion of our country from the rest or to enfeeble the sacred ties that make us one."

Ladies and gentlemen, these words of George Washington apply to our self-government, our autonomy, our responsibility to our fellowmen, and to the sacred ties that make us one of the learned professions, that truly make us a doctor. It falls to each of us to be those anxious, jealous guardians of our profession; to embrace the joyous task we've been given to continually try to improve this great profession of ours. I say this because, for all our outward differences among the various specialties, we all share the same proud title of Doctor.

Ultimately, that is what our profession demands. It needs you. Not just when there's an election, not just when your own narrow interests are at stake, but over the full span of a lifetime. If you're tired of arguing



with yourself as you drive down the highway, try calling a colleague and together set out on a path to make things better for your fellowmen and for your profession. If something needs fixing, lace up your shoes and do some organizing. If you're disappointed by your leadership, grab a clipboard, get some signatures, and run for a position on the State Board of Dentistry. Get intimately involved in your local, state, and national dental associations. Show up. Dive in. Persevere. Sometimes you'll win. Sometimes you'll lose. Presuming a reservoir of goodness in others can be a risk, and there will be times when the process disappoints you. But for those of us fortunate enough to have been a part of this work, to see it up close, let me tell you, it can energize and inspire. And more often than not, your faith in dentists - and in the profession of dentistry - will be confirmed.

"Ronald Reagan used to quote a Scottish philosopher who predicted that democracies and civilizations couldn't last more than about 200 years. John Adams wrote this: "Remember, democracy never lasts long. It soon wastes, exhausts, and murders itself. There never was a democracy yet that did not commit suicide." I believe that America has proven these dire predictions wrong for two reasons. First, we have been blessed with great presidents, with giants among us. Men of character, integrity and selflessness have led our nation from its very beginning. None were perfect: each surely made mistakes. But in every case, they acted out of the desire to do what was right for America and for freedom. The second reason is because we are blessed with a great people, people who at every critical moment of choosing have put the interests of the country above their own. These two things are related: our presidents time and again have called on us to rise to the occasion. John F. Kennedy asked us to consider what we could do for our country. Lincoln drew upon the better angels of our nature to save the union.

To that end, it is up to you to make certain our profession does not waste, exhaust, injure itself, or commit suicide. The first reason is our profession has been blessed with great leaders, giants among us. Men and women of character, integrity and selflessness have led our profession from the very beginning. None were perfect; each surely made mistakes. But in every case they acted out of the desire to do what is right for our profession and our autonomy. The second reason is because we are blessed with great colleagues; colleagues who at every critical moment of choosing have put the interests of their profession and the interests of the most vulnerable of their fellowmen above their own. That is your most solemn charge.

I truly hope you will always take the time to draw upon your better nature and to always consider what you can do for your profession and the most vulnerable of your fellowmen first. If you do, there is no doubt the rest will take care of itself. If all of you do, then most assuredly, one of you will be here 30 years from now welcoming yet another group of colleagues into the most giving, fulfilling, and sustained profession, this world has ever known. Our history goes back more than 13,000 years and many think that our profession was the first specialization from medicine.

I wish I were sitting again with you today. You have been blessed with more than you could ever imagine. Please, do not take your position lightly. It is indeed a precious gift, which will require your most dedicated care and respect. I wish you the very best in all your endeavors. And, in the words of a famous English philosopher, "Never forget what you have been given; and forget what you have given away." As you embark on this challenging and fulfilling journey, all of us who have preceded you, bid you Godspeed. - Until next time, Docere, Doctor, Teach! 



#### **Continuing Education (CE) Clarification**

The SCDA receives numerous questions about continuing education (CE) requirements in South Carolina. Below are some clarifications that will answer your questions and/or concerns.

South Carolina requires CE courses for a license or license renewal. If audited by the South Carolina State Board, the licensee must provide documentation showing the courses attended, CE hours earned, date, sponsor/speaker and the subject matter of the course.

Mr. Phil Latham The licensee must maintain this information for three years from the date of any course attended. Fifty (50%) of all required CE courses may be completed online and 1 credit is earned at the rate of one CE hour of instruction.

#### Approved CE sponsors include:

- American Dental Association (ADA-CERP); National Dental Association (NDA); Academy of General Dentistry (AGD-PACE); American Dental Hygienists' Association; American Dental Assistants' Association; National Association of Dental Laboratories, or local societies and associations;
- National, state, local, district dental specialty organizations recognized by the ADA and NDA;
- Dental colleges or schools accredited by the ADA;
- American Red Cross; American Heart Association.

OSHA and HIPAA training are required by the federal government. Each dental office should have a compliance officer who should provide OSHA training for new employees and an annual OSHA update training program for existing employees, including the dentist and themselves. The important point to remember is that each dental office needs to have proof and verification of all federally required documents, plans, protocols, etc. along with documentation of the annual training for the entire dental team.

HIPAA training is mandatory for anyone who comes in contact with protected health information. This would include the dentists, receptionists and part-time/interns. Just like OSHA, proper verification must be kept to show the content of the training and the that the information was taught effectively.

It is important to remember that proper training for both OSHA and HIPAA cannot be conducted in minutes, but it does not require weeks of training either.

The South Carolina State Board will audit for CE courses including infection control and domestic abuse.

Infection control is a separate course from OSHA and the State Board requires two hours of CE every two years and each dental team member must attend an approved infection control course.


As for domestic abuse; although it is highly recommended that courses be attended to stay abreast of the most current information, CE hours are NOT required in this area. But, if anyone within the dental office sees signs or hears talk of domestic abuse, it must be reported to the local authorities.

CE subjects not approved by the South Carolina Board include:

- Business seminars;
- Marketing meetings;
- Courses dealing with personal life;
- Retirement.

Failure to complete all hours of mandatory CE shall serve as grounds to deny the renewal of a license and may result in disciplinary action against the licensee.

## **Recognize a South Carolina Dentist Serving Patients with Special Health Care Needs**By DHEC

#### 10th ANNUAL CARLOS SALINAS AWARD

The South Carolina Dental Association (SCDA) and the South Carolina Oral Health Coalition (SCOHACC) have established an award to honor a dentist for excellence in providing care to and advocacy for individuals with special health care needs. This award which began in 2007 is co-sponsored by Specialized Care Company, and nominations are accepted through the Division of Oral Health. It is named for Dr. Salinas who dedicated his academic career to the service of individuals with special health care needs and their families.

#### Requirements:

- The nominee must be a dentist licensed to practice dentistry in the State of South Carolina.
- Nominations can be submitted by anyone in the community other than the provider receiving the nomination. (Author must include name and contact information).
- A formal letter written by the person submitting the nomination; stating why the nominee should be selected.
- The letter should <u>cite at least three specific examples</u> that demonstrate how the nominee has provided exceptional care for patients with special needs.
- **Deadline for nomination letter receipt (or postmark) is June 30, 2017.** Electronic submissions are preferred. Please send to Mary Kenyon Jones, <a href="mailto:kenyonm@dhec.sc.gov">kenyonm@dhec.sc.gov</a>

#### **Ensure That Your Medical Face Mask is Providing You With Adequate Protection**

Selecting the proper face mask for your practice can be daunting. The myriad options can make it difficult to know whether you are providing the level of protection required in your practice, at the best value. In 2003, the Centers for Disease Control and Prevention (CDC) made significant revisions to its infection control and prevention recommendations. This included the recommendation that masks and eye protection with side and face shields be worn to protect the membranes of the eyes, nose and mouth during dental procedures likely to produce a spray of blood or other body fluids. The masks should protect against microorganisms with a bacterial filtration of greater than 95 percent.

Exam masks are regulated by the U.S. Food and Drug Administration (FDA). This provides a level of quality control to the end product. Manufacturers, however, can voluntarily choose to become certified by the American Society for Testing and Materials (ASTM). ASTM is an international standards organization that develops and publishes voluntary consensus technical standards for a wide range of materials, products, systems and services. More than 13,000 ASTM standards are used worldwide to improve product quality, enhance safety and facilitate trade. The ASTM Certification Program covers products for industries that desire an independent third-party demonstration of compliance to standards and/or are facing regulatory pressures to prove compliance to standards. The ASTM test methods for face masks are vigorous and thorough, ensuring that the ASTM-rated mask you select offers the appropriate level of protection for the application.

ASTM Test Methods include the measurement of:

- Bacterial Filtration Efficiency (BFE )—the filtration efficiency by percent of a face mask using viable (live) bacterial cells from one to five microns in size. The higher the percentage, the more the mask blocks the passage of bacteria.
- Particulate Filtration Efficiency (PFE)—the percent efficiency at which a face mask filters particulate (nonviable particles) matter passing through; particles range in size from 0.1 to one micron.
- Delta P, AP, Breathability—the difference of air pressure on both sides of the mask and the effort it takes to force air through the mask. A mask with a low Delta P is more comfortable and breathable than a mask with a higher Delta P. Breathability is not the determining factor in which mask to use.
- Fluid Resistance-defined as the ability of a face mask's construction to minimize fluid passing through the
  material and potentially coming into contact with the user. The masks are challenged with synthetic blood
  at increasing levels of pressure. Masks that withstand greater pressure have more fluid spray and splash
  resistance.
- Flammability-masks are exposed to flame and measured for the rate at which the material burns, determining flammability.

To know whether your current face mask is ASTM-certified and provides adequate protection, simply look at the package. The current ASTM F2100-11 standard requires that a graphic be displayed on the box, signifying the mask performance level. The new standard also changed mask classifications from a performance scale of low, medium or high to levels 1, 2 or 3. Ratings are assigned based upon the outcomes from the test methods above. A level 1 mask provides less protection than a level 3 mask.

In addition to selecting a mask with high filtering efficiency, a mask must fit well. Due to an ill-fitting mask, some exhaled air can escape it, resulting in lower in-use BFE and PFE values. In order to accommodate the varying sizes and shapes of dental staff, more than one type of mask at all necessary levels should be provided for your practice's employees.

The CDC recommends that a fresh face mask be used with every patient order to prevent the cross-contamination from infectious materials. Additionally, a wet mask has diminished protective properties and should be changed during patient treatment.
