Dr. Carter Brown Selected for the 2012 Hoffmann Award

But there is so much more to the story! As many of you may know, Carter has been active in the SCDA and the AGD as well as his community for his entire dental career. Since graduating Furman University and then MUSC in 1982, Carter has been involved with the Pankey Institute, taught and been honored by Greenville Tech. Carter has also volunteered for many charitable events often using his musical skills, many of you may be familiar with the 9th Row, but did you know he performed with the Greenville Symphony for almost 20 years? He is a graduate of Leadership Greenville, graduate assistant trainer for Dale Carnegie, served numerous boards including AHEC, the United Way, the American Cancer Society of Greenville, Savoyards Opera Co and Kiwanis.

Carter has been the energizer bunny with the AGD, so to speak. He is finishing his term as trustee of the 19th district. He has served as SC secretary/treasurer, delegate and editor for region 19. He has served on numerous boards and committees. He has also been web master and AGD liaison to the ADA. Most recently with the ADA he has served as chair of the council on communications.



The Paper Problem: How Long Should I Keep Patient Records?

Do you have a paper problem? Now more than ever, dental offices seem to be bursting at the seams with patient records. Every new patient that comes in the door requires a stack of new paperwork to be filled out. Every time an existing patient visits for a cleaning, paperwork is necessary. From patient charts to x-rays, it may seem like your filing cabinets are overloaded with papers. For those who are quickly running out of filing folders, we have good news for you: The records can be destroyed...eventually.

Even though these records may be a nuisance to you and your staff, they are necessary for many reasons. First, before you break out the shredder, realize that the law requires you to keep patient records for a certain period of time. Specifically, a South Carolina statute states that dentists shall retain their patient records for at least five years or else face a penalty of up to ten thousand dollars for each violation. That five year requirement begins to run from the last date of treatment. After that period, a dentist is free to destroy the records appropriately.

However, even though the law allows a dentist to destroy records after a five year period, it is wise not to do so. This is because you want to be able to properly defend yourself against a malpractice claim if one ever arises. As you may know, in malpractice actions it is important to show that you adhered to the applicable standard of care. A patient's chart and other records may be vital in proving to the court that you did as you should have.

But before you fret over documents that you may have already destroyed long ago, it is important to note that dentists are not subject to unlimited liability for all alleged instances of malpractice. Instead, under South Carolina law, a medical malpractice claim is barred after six years. Thus, it would be prudent to hold on to a patient's record at least one year after the legally required five year period.

However, there is an important exception to the six-year limitation on medical malpractice claims. If the patient is a minor on the date of the treatment giving rise to the malpractice claim, then the time period for filing that claim is extended up to seven years. Thus, a dental office may want to keep a minor's records on hand until that patient is over 25 years old.

As you can see, there is no magic number as to when you should destroy a patient's records. If possible, it may be best to keep the records intact until after the patient can no longer bring a malpractice lawsuit as described above. Your filing cabinet may start to buckle, but at least you will be doing your best to fend off any claims down the road.

Giving 101

As a volunteer for the college and past president of the South Carolina Dental Association, I have learned a great deal about the college's need for private support and the logistics of how it works. Because I feel there is confusion about how and where to give to the college, I wanted to provide an explanation of the process.

In the past, the college was predominately supported by the state. That is no longer the case. When I attended school, 80 percent of the college's budget was allocated from public funds. That amount is reduced to 10 percent now and still in decline. Private contributions are increasingly important for growth and progress at our school. Projects you have heard much about in recent years, such as the new clinical building and the simulation laboratory were, in part, funded through private dollars.

When private contributions for the college are received at the Medical University, they are deposited into specific dental medicine accounts called "funds" for the benefit of the college. The entity that manages and invests the accounts for the entire Medical University is called the "MUSC Foundation." That is why your donations are made payable to "MUSC

Foundation" and why you receive a tax receipt from the foundation.

The MUSC Foundation was chartered in 1966 as a charitable, education foundation to support the education, research, patient care and other programs at the Medical University. The foundation is a 501(c)(3) tax-exempt organization, contributions to which are tax-deductible. As a private, independent entity, the foundation can invest, manage and disburse its assets in ways the Medical University and other public institutions may not. As a result, the foundation is able to borrow or leverage its assets to benefit the college.

The MUSC Foundation currently manages more than 30 accounts or "funds" on behalf of the college. Some are endowed, meaning only a portion of the interest accrued each year is spent. Endowed funds may be established with a minimum of \$50,000 and are a permanent source of income for specific purposes at the college. Other funds are not yet endowed and will require additional contributions to bring them to a permanently-endowed level. An exception is the college's Annual Fund, which provides support for students in a variety of ways each year. It is not meant to be endowed but is a vehicle for alumni to make annual contributions that are used at the dean's discretion.

If you make a contribution to the college, you may designate it to any of the college's funds at the MUSC Foundation. For example, some of us might be paying off a pledge to the Building Fund but have also contributed to the SCDA Endowed Chair and are supporting the Annual Fund every year. Each of these funds has a specific purpose. If you happen to support those three funds, you are 1) helping pay the loan that was incurred to build the new clinical center; 2) helping endow the college's first chair to supplement a faculty salary; and 3) helping students. A list of all the college's active funds is shown at the bottom of this article.

When you make a gift, you may accomplish it in multiple ways and with various types of property. The MUSC Foundation accepts cash, checks, credit cards, debits, stocks, personal property (in kind) and real property (real estate). These contributions may be given outright (all at once) or paid in time with a deferred or planned gift (funded at the time of your death) or through a pledge.

A pledge is a commitment by a donor to contribute a certain amount within a specified time. It is a signed document housed at the MUSC Foundation. Of course, a contributor can still give over time without signing a pledge. However, signing a written pledge is helpful in several ways: It can authorize the foundation to automatically pay payments through credit or debit, it can set up an automatic billing system to remind you of your payments, and combined with other pledges, it can help the dean borrow funds and secure grants for the school. This is the "multiplier effect" which I have referred to in previous articles.

Another way to make a gift to the school is by including the college in your estate plan. With gifts such as bequests through wills, gift annuities, life insurance, charitable remainder trusts and retained life estates (giving real estate now but maintaining use of it until death), you become a member of the college's Legacy Society and can accomplish things immediately like naming a room or writing the language to establish a future fund. Some gift vehicles can have tax advantages, too.

To contribute a one-time gift or a recurring gift:

Out of the Past

The year 2012 has several meaningful anniversaries for dentistry in the South Carolina Dental Association. Several momentous events took place 60 years ago back in 1952.

At the House of Delegates meeting at the Annual Session of the SCDA in Greenville, May 18-20, 1952, Dr. Carl Busbee made the following motion: "That the incoming President appoint a committee and direct it to continue the necessary study and surveys incident to the needs as a basis for establishing a dental school. This committee is to report its findings to the Association."

Thus the newly installed President of the SCDA in 1952, Dr. Clarence Saunders, named Dr. Carl Busbee the first chairman of the Dental School Committee that was composed of three representatives from each of the four districts.

SCDA members, strictly on a volunteer basis, raised over \$2000 to finance the survey of the Dental Manpower Needs of South Carolina. Dr. Joseph F. Volker, the Dean of the School of dentistry at the University of Alabama, a pre-eminent figure in American dental education, was commissioned to make this survey. He spent the months of July and August of 1952 in South Carolina to accomplish this task.


In making his report, he stated that the ratio of dentist to population of 1 to 4500 in South Carolina was among the most unfavorable in the nation. He recommended that the establishment of a dental school at the Medical College of South Carolina (now MUSC) would be a tremendous step to alleviate this poor ratio.

Therefore a special called meeting of the general membership of the South Carolina Dental Association was held on December 4, 1952 to act on the Dental Survey Report of Dr. Volker. After much discussion, Dr. Bill Draffin made the following motion: "I make a motion that this Association go on

record as adopting the recommendations of Dr. Volker for a class "A" dental school, a fully accredited one, and the Association give its full support."

The vote was 53 to 1 to establish a dental school in South Carolina. And the rest is history. A few months later in April, 1953, the legislature approved the establishment of a dental school in South Carolina, although it took until 1963 for the funding process to begin.

Thus the year of 1952, exactly 60 years ago, was a pivotal one towards South Carolina having its own dental school.





Executive Director's Notes

Each year during the spring, the State Legislature is in full gear. With everyone up for election in November, there is a possibility little will be accomplished. The same applies on the National scene with it being an election year. Despite these facts there have been several items that affect the dentists and just in case you have missed it, we wanted to make you aware.

STATE POLITICS

Several weeks ago, every SCDA member received several emails regarding the adult dental Medicaid program. The SCDA Board made a decision to move forward with a proviso to reinstate the program. We realized the fight would be very difficult giving the process and situation at the State House, but the SCDA leadership felt it was the right thing to do not only for its members, but for patients in South Carolina. We had over 500 dentists open up those important emails that provided detailed instructions on how to contact your legislator and what to say.

It was disappointing, however, as we had less than 50 dentists make contact as instructed. We live in a different political environment now, and a quick response is crucial. Whether this is an issue of noninterest, or one of us using an ineffective means of communication, WE MUST HEAR FROM OUR MEMBERS ON HOW WE CAN BEST SERVE THEM.

On another local issue, SCDA's non covered services bill has received its first hearing at the State House in the House of Representatives. This will be a huge issue also as we must go up against the insurance companies in South Carolina. This legislation has been successful in several states and we hope to add our name to the list. Although the bill did not get voted out into full committee, it was “deferred debate” which means it will come up again in a couple of weeks for discussion.

NATIONAL POLITICS

A bill that has long been dealt with by the American Dental Association received some great news last week as the United States House approved an amendment to repeal the insurance industry's antitrust exemption.

See below directly from the ADA:

The U.S. House of Representatives this morning approved by voice vote an amendment that would repeal the McCarran-Ferguson Act's antitrust exemption as it applies to health insurance companies. That exemption, which Congress enacted in 1945, was intended to make it easier for states to regulate insurance without federal interference. The ADA and other health care groups have long argued that the exemption gives the insurance industry an unfair advantage in the marketplace. Rep. Paul Gosar (R-Ariz.) offered his legislation as a floor amendment to the ADA-supported Help Efficient, Accessible, Low-cost, Timely Healthcare Act (H.R. 5).

Central District Latest

At our Spring Meeting on March 2, 2012, the Central District Dental Society hosted renowned speaker Dr. Howard Glazer with 115 doctors and staff present. Dr. Glazer presented a wide range of dental material “pearls”. One device, a composite oscillator, was invented by CDDS member, Dr. Coty Fishburne from Rock Hill. Demystifying PCI One Guideline at a Time

At first read, the Visa/MC PCI requirements seem overly technical, complex, and frankly daunting to most merchants. Digging a little deeper, many of the guidelines actually represent sound business practices that make good common sense in all aspects of daily work. One such example is the PCI requirements about the use and management of passwords.

In today's ever increasing electronic, internet, automation business environment, the day starts for most of us with logins and passwords. Punching into a time clock is replaced with logging into e-time on networks. Retrieving messages from an answering machine is now replaced with data entry of a PIN. Opening software systems, the day's appointment schedule, accessing archived files, all are tied to passwords today! As our world has become inundated with PINS, logins, and passwords, the original privacy or security intended to the holder of these "magic keys" has often been compromised by inadvertent misuse. Examples of fairly standard practices with passwords today that might be worth a closer look:

1. New systems that come with a default password from the manufacturer have never been revised by the end-user. If in your practice staff is using **welcome1**, or **sample1**, odds are it's the original default! While it is simpler perhaps to keep the password that is there when you first load the tool, anyone who was ever trained on that product (and every hacker in the world!) could enter the tool unimpeded and steal, edit, or eliminate data.
2. Passwords are changed from defaults, however out of fear that too complex passwords will be forgotten or miss-keyed, "standard" or "common" passwords are set for office tools. If staff is using **abcd**, **12345**, **11111**, or similar basic patterns for PIN and passwords in your practice, while they are easy to remember, they're also each to crack by anyone set on accessing or breaching your data! Hackers run programs that try to break into systems by guessing password types. Within seconds they can tell the number of characters required, and their tools usually begin at that point to use these basic patterns, selected by many to be easily remembered.
3. Many tools are used by multiple staff so for ease all staff shares an access password. In this example, internal exposure is at risk; if as a staffer I realize I could manipulate data or retrieve and be undistinguished from all other users, you're inviting problems.
4. Staff resignations or terminations are high impact to healthcare practices with immediate concerns over work-loads, client connections, training burdens, recruitment of replacements, etc. To avoid more stress for existing staff, deletion of old access ID's or changing of shared ID's aren't required or not done immediately. Anyone who leaves your business with an active password represents a threat to the security of your physical and network systems.
5. With a diverse distribution of tasks in an office each staffer's access provides ability to perform all functions so they don't have to wait on other staff for completion of any task. While this seems expeditious for daily work flow, it removes systemic change control from your business. Managers, supervisors and designated specialty staff should have over-sight hierarchy access to protect against completion of tasks that are highly sensitive and or negative impact on business operation. Not all staff can understand implications of all functions and not all should have access passwords to perform what they may not understand, or that might tempt mishandling.

Good password management is a smart business protocol not a technically complex, limited to credit card PCI issue. If you recognize your practice in the examples above, begin to build and implement improvements today. It's just good common sense!
