## **"I See Potential In You", Leadership In Action**

The SCDA Board of Governors held the first Leadership Conference in what is expected to be a recruitment and educational tool to recognize new leadership candidates. During last year's annual seminar for the incoming officers a "brain-storming" session recommended that the association stage a leadership conference similar to successful events held in other states. Dr. Betsy Jabbour was the point person for this special project.

Friday, January 21st more than 60 attendees came to Columbia for the first of a series of programs to groom leaders for the SCDA. The target audience were young dentists and established practitioners who wished to get involved in organized dentistry. A number of speakers shared perspectives upon the different professional pillars that support organized dentistry.

Leadership insights were offered by Drs. David Watson, Hal Fair, Gary Oyster and Jim Mercer. Much of the initial dialogue was personal stories from each of these doctors about how they came to be involved in dental leadership roles. Each dentist described the responsibilities for their different tasks in organized dentistry. But the primary theme was one of investment in the profession that the attendees have chosen. Leadership must come from within, and re-enforce the core values and goals of dentistry. Each speaker may have had a different path that called them, but each dentist had developed a global view of the professional landscape. A perspective that said, "This is important to dentistry, and I must be involved".

Dr. Watson described a common path that many in leadership roles have experienced, the power of potential. "When I started dentistry in Greenville," David shared, "I was mentored by Dr. Jim Gaines. And at that time, Jim said you should do this and that, affiliate in these organizations and you will do well. And he was right!" Today the new dentists have a sense of freedom and independence. However, there seems to be a less well defined path for success in practice and organized dentistry. "What Dr. Gaines said to me was, 'I see potential in you', and he encouraged me into leadership. That is what we want to do in SCDA for our next generation of leaders."

At the end of the seminar, Dr. Jabbour enthusiastically challenged the attendees, many of whom had never held office, "It is my wish that each participant to be present, both in body at meetings, financially with PAC Commitments and in mind by signing up with cap wiz, the ADA's and ADPAC's email alert system to important legislation." She continued, "It was obvious to me that the wheels were turning in the minds of many and several wonderful ideas for beginning and growing legislative relationships were suggested."

"I am so looking forward to our second seminar in the series in March!"

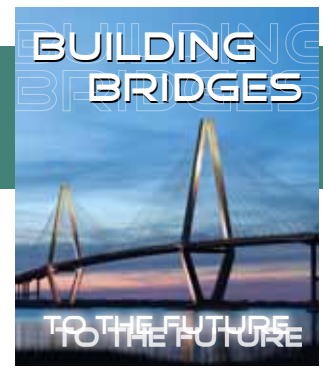

# President's Message

## DENTAL LEGACY SOCIETY

Since the MUSC Dental Alumni Weekend will be held at the end of this month, February 25-27, 2011, it seems that this is an excellent time to focus on the recently

established Dental Legacy Society. The purpose of this group is to encourage alumni and friends who support the school to also include the James B. Edwards College of Dental Medicine in their estate plans. This will launch a strong permanent endowment that provides student scholarships and endowed chairs for faculty. Last month I outlined the history of the college which concluded that rapidly declining state funding is essentially turning the school into a private institution. In light of this fact, it is clear that a strong and steadily growing endowment is vital to the future of the college. The college is truly a world class teaching and research institution. If you have not seen the new facilities in person, you need to come to Charleston and do so. Even if you are not an alumnus or alumna, you owe it to yourself to make the trip. You may contact Stephanie Oberempt at (843) 792-6933, oberempt@musc.edu, and she will be happy to arrange a tour for you. You will be impressed. I guarantee it!

When construction of the new clinical facility began in 2006, it required almost a year to drive the hundreds of huge pilings through the soft marshy soil of the Charleston peninsula to establish a strong permanent foundation firmly planted in bed rock.

We now have a physical plant which will last well into the future, but we all know that

the true strength of any educational institution lies in the quality of its faculty and students. Our challenge now is to build a financial foundation to support them that is even stronger than the bed rock on which our new building rests.

This task will take even longer to accomplish than driving those pilings did, but the sooner we begin this worthy enterprise, the sooner we will reach our goal.

Last month I established the fact that the college is a unique and irreplaceable asset and how critically important it is for today's dental professionals to work together to ensure that all of CDM's programs, facilities, and faculty continue to be the "cutting edge" and thus make certain that the college will remain the principal source of exceptionally well-trained dentists for future generations in South Carolina. This goal may be aptly attained through the aforementioned Dental Legacy Society.

Alumni and friends of the college have already initiated a strong foundation for the college. The college was founded in 1971 and has graduated 1884 alumni. Since 1973 the average gift for all alumni has been \$7123. 76 percent of graduates have made contributions to the school. Of that 76 percent (1424) the average annual gift was \$9425. Alumni gifts since 1973 have totaled \$13,420,617, which for a relatively young school is commendable; however, if we hope to create a meaningful and lasting legacy we must strive to do even better in the years ahead. Obviously, it is impossible to mention all of our contributors in this limited article, but I did want to applaud a few who have made significant commitments toward starting the Legacy Society and whose shining examples will hopefully inspire others to become more involved. This distinguished group includes - but is certainly not limited to - the 1st gift of \$ 100,000 from E. Gaither Bumgardner (endowed fund through a bequest), our college's namesake Dr. James B. Edwards and his wife Ann (endowed chair through life insurance), Dr. and Mrs. Cotesworth P. Fishburne, Jr. (Clinical Education Center through a charitable trust), Dr. W. Carter and Kathryn D. Brown (Advanced Education in General Dentistry through a bequest), Dr. Harold Z. and Felice L. Hirsch and family (endowed chair through life insurance), Dr. and Mrs. Lynn Wallace (periodontics operatory through a deferred gift annuity), Dr. Olivia C. Palmer (endowed chair through a bequest), Irene and Dr. Harold Jablon (Center for Diagnostic Sciences through life insurance), Dr. and Mrs.

Richard DeChamplain (oral surgery clinic through real estate), Gary and Dr. Benetta Bell (minority scholarship through life insurance). These are only a few of those who have generously supported the college through estate gifts; and I have listed them in order to provide examples of the many possibilities available.

For most of us, the idea of contributing \$1,000,000 or even \$100,000 to any cause might seem out of the realm of possibility; however, through an estate gift, larger contributions become possible and will provide an even stronger future for the college. Additionally, if we work together with our current giving, reaching a goal of this magnitude becomes very possible. Since the school opened, 39 classes of approximately 50 have graduated. Hypothetically speaking, if every member would commit to give \$2000 per year for 10 years the college would receive \$100,000 per year and, amazingly enough, in 10 years the class would have a fully endowed fund of \$1,000,000. With 39 classes, this would mean an endowment of \$39,000,000 for the college. I think that this scenario demonstrates the huge potential of pooling our resources. This kind of money would definitely provide the beginning of a very strong foundation.

Endowed funds are those funds whose principal value is \$50,000 or more. When a fund reaches this level, the principal is never expended, and only a portion of the interest is spent (the MUSC Foundation typically guarantees a 5 percent pay out) which provides an annual benefit to the college (scholarship or professorship) while providing growth back into the fund for inflation. Presently the college has only about a dozen endowed funds, with a total value of around \$677,000, and most of these are not yet fully funded.

Thus far, only two classes, the Class of 1974 and the June Class of 1973, have initiated the procedure of endowing a fund, and I would like to close by issuing a challenge to the other 38 classes to set up an endowed fund for every class by the end of 2011. This is an ambitious goal, but the sooner we begin the process, the sooner we can hope to achieve that goal. Building a large permanent endowment is the key to securing the future strength and success of our beloved James B. Edwards College of Dental Medicine.

# Executive Director's Notes

There has been much discussion about the Medicaid program over the last few months. Most recently has been the concern regarding the financial situation of the Medicaid budget.

Medicaid has been around since 1965 and the "safety net" for coverage has expanded through the years. In South Carolina, Medicaid covers approximately 43% of all South Carolina children and 53% percent of all births. Believe it or not, Medicaid accounts for over \$1 billion annually paid to dentists, physicians, hospitals, nursing homes and other providers.

Although the South Carolina Department of Health and Human Services (SCDHHS) who manages the Medicaid program has worked to maintain an efficient program, it has reached a point where expenditures are outpacing the resources allocated.

By the end of the current fiscal year, 2010-2011, SCDHHS projects a shortfall of over \$200 million. This shortfall takes into account the extra funds under the American Recovery and Reinvestment Act and it assumes at ten percent growth in expenditures.

What caused this major shortfall? Mainly, it is the 100,000 added to the Medicaid rolls since December 2007. Since the federal government prohibits any altering of eligibility standards, South Carolina has not been able to manage the increase. This prohibition is part of the new federal health care reform law. Another reason for the shortfall is that SCDHHS has had major budget reductions over the past three years. Budget cuts and monies transferred to other state entities have reduced the budget and depleted reserve funds. Lastly, South Carolina is the only state that has a proviso in place that blocks the agency from reducing provider fees.

With those facts, SCDHHS has to make some major financial decisions. Those decisions include eliminating optional services which includes adult dental. SCDHHS has estimated that elimination of this program will save just over \$3.5 million dollars in a fiscal year. The agency has also pointed out that while this may provide some short term savings, it could have financial implications on other agencies.

When your Association learned that the adult Medicaid program, which is an optional service, was being considered as one program to eliminate, we immediately prepared a letter and sent it to the officials at SCDHHS and all of the major legislators who will play a role in these budget discussions. The SCDA letter provided a side by side comparison of what would occur if an adult patient could not find dental care and sought treatment in the emergency room. The numbers do not lie; there is more than double the cost to the state when this occurs. Even more important is that if that same adult patient had access to a dentist, the problem would be solved, but by visiting the emergency room, the problem is not solved and likely will reoccur.

SCDHHS has many other ideas about what to do regarding the major budget shortfalls, but no matter what decision is made, it will affect the dentists in one way or another. The SCDA will have an appearance before major lawmakers soon to voice our concerns over the decision to eliminate the adult Medicaid program. We will also be involved in any meeting where these discussions will take place. And, as always, the SCDA will communicate to the membership any major decision(s) that may take place.

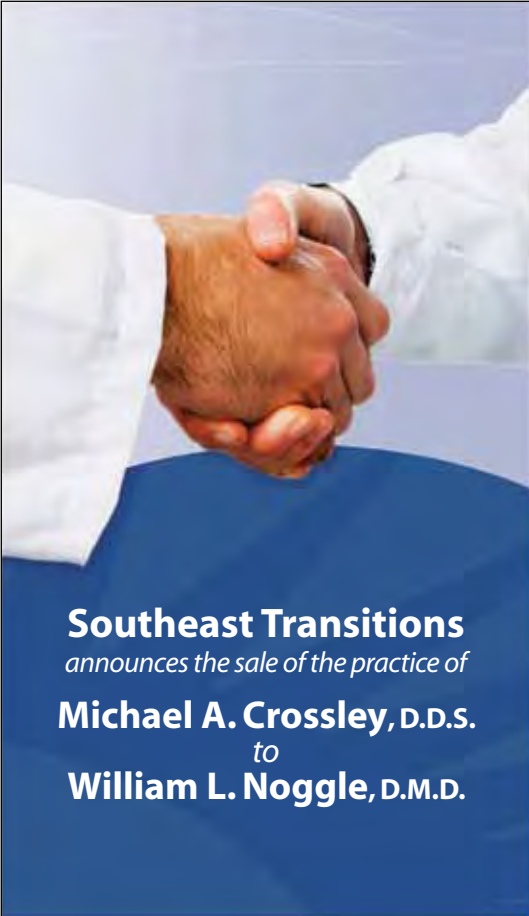
