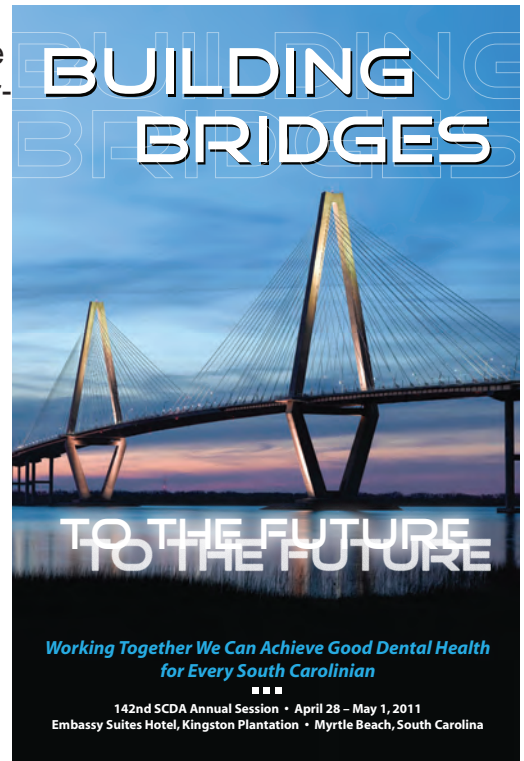
help answer questions and concerns on Medicaid.

## SCDA House Approves Overhaul of Bylaws

The SCDA House of Delegates approved to accept the bylaws changes as presented by the Constitution and Bylaws Committee. The modifications that were required represent an effort for the SCDA to become compliant with the Constitution of the ADA.

Many of you may recall that this presidential term for Dr. Wise is designed to last 18 months. In December of 2011, all committees and officers will rotate into new positions. Some of the challenges that prompted the bylaw changes included financial contributions that have been out of step with the national association. SCDA collects membership dues at the end of the calendar year, consistent with ADA. However, the association corporate year has historically ended in June. Therefore, the officer rotation occurred on July 1st.

Until the cycle is completed, a number of subtle applications will need to occur. Realignment of the Annual Session will present some changes in the format

and agenda. The bylaws still set aside a meeting for the spring season, but the meeting will no longer require installation of officers and end of year reports. New officers coming into the association will be recognized during the December House of Delegates. The planning retreat will be scheduled for November or early December.

It has always been a trick to plan for the budget of the SCDA. Historically, membership revenue is collected in December, but the budget ended in June. This change will make planning and accounting practices easier. At the HOD meeting in Myrtle Beach the budget that will be voted upon will be a six month interim budget.

Phil Latham and the SCDA expect the transition to be seamless and in the completion strengthen the association.

## Red Flags Lowered

The ADA has persevered in our debate that dentistry should be excluded from compliance with the FTC mandate on Red Flag Rules. As a reminder, Red Flags were designed to assist in identifying transactions that could indicate fraud or ID theft. The rub occurred when dentistry and medicine was lumped in with small businesses. This then interpreted doctors to be “creditors” due to transactions in the practice. This was another layer of mal-imposed regulation.

At this time, it is believed that this will signal the resolution of the Red Flag Rules applied to the dental community. Time and circumstance will tell.

## Medicaid Coverage “Runnin’ on Empty”

There was a note in the paper last month that the Medicaid program in South Carolina was quickly approaching a short fall in funding. The information available indicated that South Carolina’s legislature was unable to fully underwrite the money to keep the program afloat. If the money was not secured, then there was a loss of matching federal funds that make up approximately two thirds of the resource.

The “request” from DHHS was that doctors continue to see eligible patients even though there was no assurance of payment for services rendered. How can that be? Are practitioners expected to fund the Medicaid program? The crimp in the pipeline is occurring due to overall shortages in revenue. There is a serious expectation that by February 2011, adult Medicaid will be discontinued. No coverage, nada, nothing for adults. The agency has requested that the state allow DHHS to continue to function in a “budgetary deficit”. This would mean that activity would be continued, checks sent to pay for service, but the DHHS funding would be at a loss until South Carolina makes up for its shortfall.

Voting is occurring as this article is being written.

## Silver Resolution for the New Year!

It is now time to make and keep your New Year’s Resolution. That promise would be to install an amalgam separator in your office. 2011 must be the “Year of the Separator” if dentistry is to avoid punitive restrictions on the use and disposal of amalgam. Just last week on NBC there was an update about the FDA and its revisiting of mercury contamination from amalgam in dentistry.

I believe that the emphasis was on mercury as an environmental concern not as much as a health issue. But in the press, and to concerned patients, the connection might appear to be a condemnation of a successful 100 year restorative material.

Whether you believe that your office contributes to ground or air contamination is secondary to the pending requirement to install a trap to collect amalgam. The contents can then be recycled and disposed of according to government guidelines. Do it to avoid further restrictions.

**As you read this editorial realize the persistent efforts made on our behalf by organized dentistry! You are a part of the ADA and the SCDA! Be involved.**

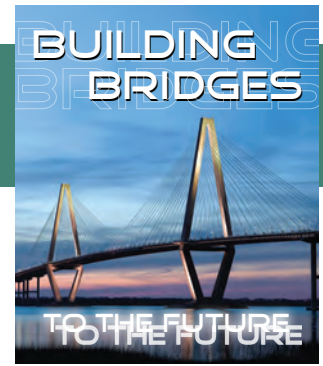

# President's Message



## MUSC College of Dental Medicine: Our Legacy for the Future

Our theme for the SCDA 2010-11 year is "Building Bridges to the Future" and I wanted to take the opportunity to talk about one of our most important bridges to the future, our own amazing James B. Edwards College of Dental Medicine. I use the term amazing because I am keenly aware of the difficult financial constraints under which Dean Jack Sanders, his remarkable faculty, and their predecessors have been working for many years. In spite of this, they have managed to create a "state of the art" teaching facility and a collegial learning environment which produces some of the best clinical dentists of any school in our country. The College is a world class institution and as such, it is a very precious resource for the future of the dental profession in our state.

In order to substantiate the foregoing assessment of our college, I would like to touch on a number of facts about the school which are important for every dentist in the state to understand. As we all know,

the state has experienced a significant decline in revenue since the economic downturn began in 2007. Higher education and especially graduate programs have received an inordinate share of the resulting severe budget cuts. In 2002, the College of Dental Medicine (CDM) received \$6,302,385 or 48% of its annual revenue from the state. As of July 1st, 2010, the state support was down to \$3,204,735 or 15.4% of CDM's total budget. It is anticipated that a potential \$600,000 cut in 2011 will reduce the state support to below 10% of the overall budget. In essence, the college is "state-supported" in name only and is operating much more like a private institution than a public one. These numbers clearly indicate that to state that the staff and faculty work under "difficult financial restraints" is no exaggeration.

The college was started in 1971 with a class of 24 students, which grew to a class number of 50 and then, most recently, 70 incoming students. As a relatively young school with a small number of graduates to contribute to establishing endowments, CDM is at a distinct financial disadvantage compared to older and better-endowed schools in our region, as well as around the country. In spite of these limited resources, the strong leadership of Dean Sanders and his dedicated faculty continues to produce high quality graduates, who consistently score well on national board exams and are known to be well-trained clinical dentists. The College of Dental Medicine has just completed the ADA recertification process (which occurs every seven years) and has received word that at the official meeting in January of 2011, the CDM predoctoral, periodontic, and pediatric programs will be recommended for accreditation "without recommendations." (Oral Surgery and Orthodontics were previously accredited during different cycles). This "without recommendations" status rarely occurs in the accreditation process, and

it clearly indicates that the education programs at our College of Dental Medicine are exceptional. In addition, a new AEGD program received initial accreditation and a 1.7 million dollar grant was awarded to initiate the program. A significant pledge from Dr. Carter Brown and his wife strengthened the application and helped to create a multiplier effect which attracted additional funding to the program. This result illustrates why building a strong and growing Dental Legacy Society is so vitally important.

At a recent meeting of the Dean's Diversity Council and the SCDA Diversity Committee, it was decided that we would hold a fundraising event at our upcoming annual meeting featuring current ADA president Dr. Ray Gist, who is the first African-American president in the history of that organization. The purpose of this event is to raise funds to endow a scholarship for African-American dental students. It is hoped that this, along with other generous gifts and pledges by friends and alumni of the college, will provide a "multiplier" effect for the Dental Legacy Society so that it will become the endowment vehicle which is so essential to the long term strength and success of CDM. Since this article does not focus on the Legacy Society, I purposely have not provided specific details at this time but will do so in the near future, in a subsequent article. Clearly, the establishment of a strong and steadily growing endowment program is a key element for the college's future.

One final area that I do want to touch on is advocacy of our members in soliciting support for the college from our legislators. Dean Sanders has indicated that the Rural Dentist Incentive Program, which SCDA encouraged the South Carolina legislators to pass several years ago, is vitally important to the college because of the role it plays in helping to attract and retain promising young faculty members. The bill provides loan forgiveness for recent graduates who practice in underserved areas and to those who choose to enter the field of dental education. With the limited funds available for faculty salaries, it is likely that without this program, the college will lose a number of excellent young educators who are obviously essential to the future of CDM. It is important that the members of SCDA make a special effort to tell South Carolina legislators what an exceptional dental school we have in our state and how important programs like the Rural Dentist Incentive and other funding issues are to keeping the college well-equipped and staffed so that it can continue to supply an excellent source of future dental healthcare providers for the people of South Carolina.

We should all be very proud of the outstanding institution that our College of Dental Medicine is today. Previous generations of South Carolina dentists (SCDA leaders, educators, and many others) worked together to create something wonderful for the people of our state. It is unlikely that we could recreate CDM in today's culture so it is a unique treasure well worth protecting and defending. One of the most crucial elements needed to do this is the establishment of a strong and steadily growing endowment program. It is my sincere hope that we can marshal the support from SCDA members and others to get behind this effort and make it happen.

### What Does Supplement Coverage Entail?
