
The Path Is Unchanged, A Perspective

These are indeed troubling times. Many patients are cautious about care as they are concerned about their jobs and resources. The country is languishing economically and dentists are often fretful about their future. Their schedules are not as full or appointments are not booked as far out as they once were. I have been party to conversations with newer dentists asking if things have ever been like this before. They wonder, rightfully so, if this is an insurmountable situation that the country is experiencing, that dentistry is experiencing. And yet for many older practitioners, the events seem to be replays of other times.

I graduated from MUSC in 1973. We were the boomers and the perspective was that we were moving. The Vietnam war was over and many veterans had returned home and the economy seemed to be picking up. However, there was also a perspective that the country needed more dentists to care for the growing population. The population tidal wave was looming and we were it. So the government encouraged graduate schools to ramp up their enrollment. Subsidies were actually paid to schools to put more doctors into the system. In

a few years the folly of this exercise produced more dentists, but the overwhelming need never really materialized.

So as more dentists graduated over the next few years, the prospects of a quick start for the practice seemed slim. To make national matters worse, there was an oil embargo that stalled the economy and produced gasoline rationing. Jimmy Carter was a one term president who indecisively led the country. When



These dynamics contributed to a period when there developed a "busyness" concern in dentistry. Practices were worried about patient traffic in their offices. This was about the time that insurance companies and benefits were entering the South. Many dentists did not want this intrusion, National Healthcare Seminar but it did help the recovery from the slow down. In 1983, a record 5,736 dentists graduated from a total of 60 dental schools. I had built my office in 1979, married that same year, and our expectations were high. Luckily, my wife worked in sales and the double income was a blessing. In October 1987, the Dow lost 20% of its value in a single "black Monday".

Real estate inflation became an investment strategy. With interest rates above 14%, the value of homes was racing into uncharted territory. So was oil. So were the savings and loan companies. And after years of aggressive financing of escalating home values, they suffered a collapse that contributed to a recession. This was in the early 1990s. In 1993, the number of new dentists graduating from 54 dental programs was a low of 3,778. The recession did have the financial impact of forcing rates into the single digits and property values declined. The country was on a bit of a rebound and investments were improving.

In the late 1990's however the business world became enamored with the technical sector. The dot-com world of finance seemed to be a sure thing that could not stop. Yet in the turn of the century, that balloon exploded. The NASDAQ crossed the 5000 mark in 2000, and by 2002 it had lost more than \$5 trillion for investors. It was a dark economic time for the country. It was also the time of the most tragic domestic event to occur with the destruction of The World Trade Center. Another war in Iraq and a loss of confidence over the next decade have defined the economic picture. Many citizens are unsure about the future. Many dental offices were asking other dentists if they were feeling the slow down. The only assurance was that the trend was mostly universal.

In 2007, the number of dentists graduated reached 4,796. Today's dentists survey appointment schedules that are not full more than a week out. They see patients who may delay necessary care, and possibly an increase in the collection rates of the practice. More people in South Carolina are entering the Medicaid rolls and it is likely there will be a few more years of lagging economic indicators. Can the professions flourish, or just survive?

I do not have a crystal ball to tell the future. But like many of my peers who have lived through this turmoil, we know there is a foundation and a momentum for dentistry. At every interval I described in this article, there was a sense of crisis. In every situation there was a risk of collapse. In every challenge, professionals must feel a sense they can still be fearless for dentistry. That care and skill overcome all challenges. And that optimism still is a choice.

So my message to newer dentists is to endure, to resist being worn down by negative conversation. Believe in yourself and your professional community of leaders. Be involved because there is a strength provided by the community of dentists. This will be another story for another time. Do not give away the profession because you feel overwhelmed. Do not yield to the easy path of commercialism. Remember that dentistry is a healing profession, and you have risen to that call. All else will be a success.

Foreign Dentistry: Patient & Professional Policies

(I will present a series of dental perspectives regarding socialized dental care. These are insights based upon communications with patients or professionals living outside the USA. I believe that the weaknesses of the system are obvious and profound.)

A patient from South Carolina worked for Shell Oil Company and was transferred to the Netherlands. This individual was a young professional with appropriate resources to care for the dental needs of himself and his family. The country of his transfer had many opportunities for first class cultural involvement. It also had a well developed and long standing socialized public health care system.

The dental system of the Netherlands provided for all residents of the country to have access to free care. As any industrialized, educated democratic nation, all of the medical systems were first rate. Care was not necessarily outdated, nor were the offices antiquated any more than those in the United States. The structure of the public medical care allowed for appointments in "assigned" offices. A patient chooses or aligns with a practice and their care is provided at that location. Service fees are handled through an insurance process similar to our Medicaid.

The Shell Oil patient developed a toothache and after some discussion and treatment, it was determined that a root canal was needed. The endodontic process was performed and the patient dismissed. Within a ten day time frame, the pain returned although not as severe. Upon returning to the dental office, the dentist stated that the patient would need an apicoectomy and retrofill. The patient contacted his domestic dentist for a second opinion. The SC dentist asked about bite adjustment, antibiotics or re-treatment. None of these venues were explored.

When the patient requested a second opinion in the Netherlands, it became clear that the socialized program did not provide for this option. The patient would need to change enrollment from the existing practice and find another practice that would accept him. To his credit, the initial dentist did offer implants and bridgework as options. However, the real concern for the patient stemmed from the barriers prohibiting transfer. He wished to simply keep his molar. Delays to change or be referred to a specialist could take months! So this patient was in a quandary.

This represents an isolated example, but when conversations with this gentleman occurred he indicated that this was the frustration of this care model. Patients are easily treated and have access to free or reduced price care, but when any issue requires further treatment then many hurdles must be covered. At the end of the day, treatment could be prohibitive and the patient may suffer.

President's Message

On August 5th through 7th, the SCDA carried out its second annual DAD project, and it was another overwhelming success. Our volunteers provided much needed critical dental care for more than 1500 adults from the greater Greenville area. This year's event also included opportunities for medical screening and referral provided by the South Carolina Hospital Association. Kudos to all those who gave their precious time and talent to help make this most worthwhile public service event a reality.

Some of our members may feel that this kind of project is not worth the time, effort, and resources required. Yes, it does necessitate a tremendous amount of time and considerable effort from over a hundred SCDA staff and volunteers, many of whom are the same 20 or 30% who participate in almost all SCDA functions; however, I do not believe that any of them consider it a waste or else they would not return again and again to repeat their contributions. I am reminded of the old proverb "Many hands make light work." The needs of our recipients are great, the task monumental, but to see the grateful expressions of appreciation from those who come to receive our services is payment in full. SCDA's mission is to serve all people of South Carolina, and our association will continue to fulfill this in direct proportion to the time and effort that every member is willing to invest. The DAD project is certainly a shining example of this in action. To those who question the value of DAD, I invite you to come out and volunteer to be an active participant. I believe it will change your mind.

Phil Latham told me about one man who came to the Friday clinic as a patient and presented himself with a somewhat skeptical attitude about what was being offered, but he was evidently so impressed with the treatment he received that he returned on Saturday to volunteer all day and even stayed to help pack up at the end. I also heard several stories about SCDA members who had expressed doubts about the value of this event but showed up anyway and in the end came away with very positive and enthusiastic attitudes. It seems that personally being part of the event transforms doubters into converted believers.

A free weekend clinic is certainly not a healthcare system; however, an event like DAD does provide for us, as healthcare professionals, an opportunity to give back a small bit of ourselves to our fellow man. Currently, one of the most controversial topics at the ADA and in every national discussion dealing with dental healthcare for the underserved involves major changes in the composition of the dental workforce and the possibility of using some form of midlevel provider to increase access. An event like DAD is certainly not a solution, but it does show policy makers that members of the dental profession are willing to work with government and public health officials to find workable solutions for the access to care problem. In essence, it lends strong credibility and validity to any ideas or other input which leaders of the dental profession bring to this discussion.

Finally, our DAD project provides every member an opportunity to experience the satisfaction one gets from giving of him or herself to others expecting nothing in return. If you did not participate in this year's DAD, you missed a great opportunity, and I hope that you will seriously consider doing so next year. It is still not too late if you would like to support this year's event with a financial contribution. I am reminded of a quote by A. Neilen, which provides a succinct conclusion to my article: "If you have not often felt the joy of doing a kind act, you have neglected much, and most of all yourself."

Executive Director's Notes

"...SCDA is tracking all of these issues and has set up a meeting with SCDHHS to express our concern..." In July, I began a series of items that the SCDA has accomplished over the years for the benefits of its members. Below are three more areas where the SCDA has worked hard to assist dentists.

Supports Gifted Dental Students in Their Chosen Field. The SCDA created the SCDA Dental Care Foundation which offers scholarships to dental hygiene and assisting students in the various technical colleges, scholarships for rising seniors at MUSC and established the Mary Clary Award program which recognizes the top dental hygiene and dental assisting student in the state each year.

Since inception of the auxiliary scholarship program, the Foundation has granted more than 250 scholarships. SCDA Member Benefits Group joined the Foundation efforts in 2006 by offering its first \$5,000 scholarship to a rising senior at MUSC. Member Benefits Group has continued to offer the award.

Put Patient Protection on the Forefront. The SCDA created a coalition and produced a Patient Protection Bill which required companies headquartered in South Carolina to offer dental plans that featured the right of employees to choose their dentists if the company's principle dental plan was a managed care product which dictated where the patient would be treated. This legislation won the ADA's Golden Apple Award for Legislative Achievement.

Made Practicing Dentistry in SC Easier For Qualified Professionals. In the mid-1990s, the SCDA initiated and supported changes that doubled the number of times a year the licensing exams for hygienists and dentists were administered. The SCDA also initiated and had legislation passed to allow licensure by credentials by dentists.

Medicaid

On another topic, I wanted to mention the subject of Medicaid. I realize that the last few weeks have been a very trying time for many. The SCDA has heard from many of you regarding problems with payments, claims requirements, claims rejections, web portal issues, etc. Please realize the SCDA is tracking all of these issues and has set up a meeting with SCDHHS to express our concern with the program administration. We will specifically discuss each of the issues and report back to you the outcome of our meeting.

While on the subject of Medicaid, I was invited to a special meeting this past week where the Director of Medicaid along with others presented the budget issues the Medicaid Agency will be facing not only this year, but into next fiscal year 2010-2011. At this point, we do not know what may occur, but the budget shortfalls are real and with no relief in sight, we may be faced with some very difficult decisions in the near future. I urge you to read all correspondences from the SCDA as we will keep you apprised of the latest news, not only regarding Medicaid, but on other issues too.
