From this a working document will be created to help our technical schools, our State Board, CODA and our State Legislators in the development of immediate and long term solutions.

Our June Board meeting discussed many important issues including our continued legislative efforts such as our Bloodborne Pathogens Bill, Teledentistry, E-Prescribe, Botox and others. We had presentations from Dr. Sarandeep Huja, Dean of the Dental College regarding the various ongoings at the College including the James B. Edwards Endowed Chair in Oral Surgery, presented to Dr. Marty Steed, the activities at the West Ashley Medical Pavilion Clinic and the Ryan White Clinic that provides "real world" practice opportunities to our students. He also discussed a new Nexton Clinic that will be in operation sometime in late 2024 as part of the MUSC Health network. He also discussed the implementation of and use of EPIC as the electronic health record in our dental clinics, to bridge the medical dental aspects of the practice of dentistry. The Dean also discussed the new departmental restructuring, the reason for it and the implementation of such.

Planning is underway for the 2024 Annual Meeting which will be held in Greenville, SC in August 2024. This will be another outstanding meeting.

#### **Medication Access and Training Expansion**

This particular article was run in the May SCDA Bulletin, however the American Dental Association (ADA) has some additional information regarding the new law which applies to prescribers of controlled substances and the frequently asked questions have been updated, which can be assessed below.

The law is referred to the Medication Access and Training Expansion (MATE) Act and requires prescribers, including dentists, to complete eight hour of one time training on safely

prescribing controlled substances (Schedules II, III, IV, and/or V) in order to receive or renew your registration with the U.S. Drug Enforcement Administration (DEA).

It is very likely that you also received an email from the DEA in April also notifying you of this new requirement, which goes into effect on June 27, 2023.

To help dentists comply, the ADA has created a <u>Frequently Asked Questions</u> document addressing common questions we have heard from members, including:

- Does this new federal training requirement affect me?
- What am I required to do?
- How much time do I have to satisfy the new training requirement?
- Do I need to maintain records showing I have completed the training?
- How will I know what courses will satisfy the requirement?
- Will training hours completed prior to the law's passage count toward the new requirement?
- Will I have to complete the 8 hours of federally required CE on a cyclical basis?
- Will CE credits that are accepted for state licensure count toward the new federal requirement?
- Can my state impose additional CE requirements?
- Am I required to complete training on topics that are outside of my scope of practice?
- Do I have to use a specific CE provider? Will
- ADA CERP credits count?
- Does the ADA offer CE on safe controlled substance prescribing?

The ADA will update the FAQ regularly to answer new questions and share additional information and the SCDA will continue to help notify the membership of any changes regarding this new law.

## Hidden in Plain Sight: How an Office Manager Stole \$370,000

It is always both a pleasure and honor to share updates with the South Carolina dental community during the graduation and white coat season.

It could be said that the 2023 academic year is one for the record books with, a very strong performance by our students on the Integrated National Board Dental Exam, many planned and actualized curriculum enhancements, significant progress toward the longanticipated integration of the Epic health record system, and the simultaneous rollout of rusture initiatives.

We graduated the Class of 2023. Their hard work, and that of our incredible faculty and staff, especially through the COVID-19 pandemic, is evidenced by their 98% first-time pass rate on the Integrated National Board Dental Exam and their successful transition to private practice and residency programs.



**Rising third-year dental students** received their white coats. At the White Coat Ceremony on June 9, our third-year dental students took the Dentists Pledge, marking the beginning of the clinical portion of their education.



We welcomed 78 students in the incoming Class of 2027. As the state's only dental school, we have profound responsibility to prepare the next generation of leaders and providers for the oral health needs of the future. For the sixth year in a row, we have succeeded in holding tuition steady, thanks in large part to our generous alumni, friends and state support.

We announced an advancement in the college's organizational structure for the new academic and fiscal year. The goal of the department restructure is to enhance the fulfillment of the college's mission, ensure continuous quality improvement, and position the college as THE dental college known for innovation and education as it rises to national prominence. The college will function effectively and efficiently with better alignment of clinical, education, and research collaborations through a new academic department structure.
