President's Message

"See you in September, see you, when the summers through."

That song made popular by the group The Happenings in 1966, still reverberates in my mind each September. So here we are, nine months into my term as President of the SCDA and I can honestly say it has gone by quicker than I would have imagined. Your Executive Committee, Board and SCDA home office team have been working behind the scenes to help make the wellbeing of our patients and profession better.

One item of great interest is the expansion of the South Carolina Rural Dentist Program in our State. The program has been expanded to eleven from four possible participants. The funds for this program, which was implemented in 2005, are appropriated to the Medical University of South Carolina (MUSC) and are administered by the South Carolina Area Health Education Consortium. The program assists in the repayment for educational loans of dentists who practice in a Health Professional Shortage Area (HPSA) or serve as full-time faculty at the MUSC College of Dental Medicine.

The expectation is that during their commitment period these dentists will establish viable community practices or academic careers at the College of Dental Medicine, become involved in their respective communities and remain after the funding period is over. Priority for this program is given to those demonstrating need and expressing intent to remain in an underserved area or in an area of critical need at the MUSC College of Dental Medicine. We are very thankful for the efforts of Dr. Sarandeep Huja, Dean of the College of Dental Medicine for helping to engage SCAHEC in expanding this program.

The SCDA held a Workforce Summit over the summer months. This was a gathering of all the Technical Schools and their faculty, the SCDA Executive Board, SC Dental Hygiene Association, SC Dental Assistants Association, Dean Huja from MUSC-CDM, and representatives from the State Board of Dentistry. The Summit was facilitated by Dr. Amy Martin, MUSC-CDM. There was a great deal of information shared during this Summit and the participants were energized by the various panel discussions and data shared. A summary report has been created and recommendations for next steps were provided in that report. Those recommendations included:

- Workforce Retention Technical Assistance
- Continued Engagement with Technical Colleges
- Advocacy for Training Programs
- Updated Workforce Surveillance

The Workforce Summit document will be made available to the SCDA membership in the coming weeks.





Oral Pathology Diagnostic Challenge

A 5-year-old male with an unremarkable medical history presented to a general dentist with an erythematous mass on the facial gingiva of teeth #A and B of two months in duration (Figure 1). Stainless steel crowns were placed on teeth #A and B approximately 2.5 years prior. Chief complaints consisted of gingival bleeding and pain when eating and brushing. After multiple rounds of antibiotic therapy proved ineffective, he was referred to an Oral and Maxillofacial Surgeon for an evaluation. An excisional biopsy was performed, and the specimen was received at MUSC's Oral and Maxillofacial Pathology Department consisting of one tan and white, ovoid soft tissue fragment measuring 0.8 x 0.6 x 0.4 cm, which was bisected and evaluated microscopically by an oral pathologist.

CORRECT DIAGNOSIS:
C. Granular Cell Tumor

Histologic examination of this case revealed a soft tissue specimen composed of keratinized stratified squamous epithelium overlying a benign neoplastic process consisting primarily of large cells with granular cytoplasm. The epithelium was covered by a thickened layer of parakeratin and in other areas was focally ulcerated. The underlying stroma contained a benign mass composed of large, polygonal cells with granular eosinophilic cytoplasm and round to ovoid nuclei. These cells were widely distributed throughout the specimen and observed at the surgical base of the specimen. Bands of collagen fibers were seen between the granular cell proliferations, as well as neurovascular bundles and scattered chronic inflammatory cells.

Granular cell tumors are soft tissue tumors with neural (Schwann cell) differentiation composed of large polygonal cells containing eosinophilic, granular cytoplasm. These tumors are found in peripheral soft tissue of skin, oral cavity, breast, larynx, gastrointestinal tract, bronchus and trachea. When located in the head and neck area, the tongue (especially dorsum aspect) is the most common location. While usually solitary in nature, 5-15% of cases may present with multiple lesions, as reported in certain syndromes.^{1,2} More commonly found between the ages of 30-60, granular cell tumors encompass a wide age range with a slight female predominance, with the exception of laryngeal tumors.^{1,2} Clinical presentations vary from colorations of pink to yellow, white or tan mucosal masses which are usually asymptomatic. The majority range from 1-2 cm in diameter and produce a slow, indolent growth; however, up to 2% are malignant. ¹ Treatment of benign granular cell tumors is complete excision, although lesions with incomplete excisions may spontaneously regress.

DIFFERENTIAL DIAGNOSES

A. Pyogenic Granuloma

Pyogenic granulomas (PG) are common benign tumor-like growths often reactive in nature from trauma or chronic irritation. They are frequently found in the oral cavity, skin of fingers, face, and oropharynx, while less common in the conjunctiva, vulva, trunk, arms and legs.³ When in the oral cavity, the most common location is on the gingiva, followed by the lips, tongue and buccal mucosa in a broad age range, especially ages 20-40.⁴ Oral lesions are usually solitary in nature, while skin lesions may demonstrate multiple lesions. ⁵ Frequently observed during pregnancy from hormonal influences, they may be termed granuloma gravidarum or pregnancy tumor. When arising in poorly healing extraction sites mimicking granulation tissue or squamous cell carcinoma, they are often termed epulis granulomatosa. Large, pedunculated masses are designated as lobular capillary hemangiomas. Clinically, oral pyogenic granulomas vary from smooth to lobular and pedunculated masses which are pink to red or purple in coloration due to their abundant vascularity and may exhibit surface ulcerations. They often demonstrate a rapid growth rate and easily bleed, which may be concerning to patients for malignancy or esthetic concerns. Treatment with complete excision extending to the periosteum and scaling adjacent teeth to remove potential sources of irritation are recommended to reduce the recurrence rate (<15%). Increased recurrences are noted with pregnancy, with some lesions resolving spontaneously after childbirth.

B. Ulcerated Fibroma

Fibromas (irritation fibroma, traumatic fibroma, focal fibrous hyperplasia) are common benign fibrous nodules of the oral cavity presenting as reactive hyperplasia from local trauma or chronic irritation. The most common oral locations are the buccal mucosa (especially in the plane of occlusion), labial mucosa, tongue, gingiva and palate.^{6, 7} The giant cell fibroma is a variant demonstrating distinctive histology, frequently found on the gingiva, tongue and palate, and clinically mimics a squamous papilloma or small fibroma. As the most frequently submitted oral soft tissue mass, fibromas are generally solitary in nature unless syndromic. Most fibromas clinically present as asymptomatic pink, smooth-surfaced nodules unless demonstrating surface ulceration and tend to occur more frequently in the fourth to six decades of life with a distinct male predilection.⁶ Conservative local excision and elimination of potential sources of trauma remain the treatment of choice. Recurrences are infrequent.

D. Peripheral Giant Cell Granuloma

The peripheral giant cell granuloma (PGCG) is a common reactive gingival mass occurring from local irritation or trauma and may radiographically demonstrate resorption or "cupping" of underlying bone. They exclusively occur on the gingiva or alveolar ridge. Frequent ages for developing these lesions are

the fourth to sixth decade of life with a female predilection.⁸ PGCGs clinically present as red to blue or violaceous nodular masses due to their underlying vascular stroma containing abundant multinucleated giant cells and may be sessile or pedunculated with surface ulcerations. Similar to the pyogenic granuloma, treatment with complete excision extending to periosteum and scaling adjacent teeth to remove potential sources of irritation are recommended for reducing the recurrence rate (~10%).⁹ As the histopathology of a PGCG is similar to the brown tumor of hyperparathyroidism, enlarging or recurrent lesions should prompt further investigation to include serologic evaluation of parathyroid hormone, calcium, phosphate and alkaline phosphatase levels.⁸

CONCLUSION

Our case highlights the unusual location and clinical presentation of the granular cell tumor, which mimicked a pyogenic granuloma, as well as obtaining biopsies for any abnormal dental findings in patients to ascertain a histopathological diagnosis for appropriate treatment. Although lesional tissue in this case extended to the base of the specimen, there has been no recurrence.
